# PRESS RELEASE

The Minister of Public Health, Dr MANAOUDA Malachie, hereby informs Medical Doctors that in conformity with the provisions of articles 30 and 31 of Decree No. 92/265/PM of 22 July 1992 to lay down rules for the application of law No.90/036 of 10 August 1990 on the practice and organization of the Medical profession, articles 85 and 86 of the Code of Ethics of the Cameroon Medical Council (CMC) made enforceable by Order No. 5818/A/MINSANTE/CAB of 21 June 2022, and in compliance with the Very High Instructions of the President of the Republic, an Extraordinary Elective General Meeting within the governing bodies of the CMC is convened on Saturday, 9 December 2023, from 7 a.m. to 6 p.m. at the Yaounde Multipurpose Sports Complex.

This General Meeting, which comes on the heels of some Government actions initiated in collaboration with the Outgoing Council of the Cameroon Medical Council alongside the Seven candidates that were earlier declared for the position of President of the Council, is open to the 2,883 medical doctors who are up to date with their dues as of 14 December 2022, for which the list relating thereto has been published and can be consulted on the websites of the Ministry of Public Health (MINSANTE) at <u>www.minsante.cm</u> as well as that of the CMC at <u>www.onmc.cm</u>.

During the working session, doctors will respectively elect:

- The Chairperson of the General Meeting;

## For the position of the Chairperson of the General Meeting,

- be of Cameroonian nationality

- must have been fully registered at the Council;
- must have been up to date with their dues (absolutely feature on the list of 2,883 medical doctors who are up to date with their dues as of 14 December 2022);
- have at least 10-year seniority of medical practice in Cameroon;
- have no current disciplinary sanctions;
- have not been criminally convicted;
- commit to live and work in Cameroon permanently;
- commit in writing to serve the Council and uphold to ethical and professional conduct.

#### For the position of Members of the Electoral Commission:

- be of Cameroonian nationality;
- be a registered member of the Council;
- be up to date with their dues (absolutely feature on the list of 2,883 medical doctors who are up to date with their dues as of 14 December 2022);
- have at least 5-year seniority of medical practice in Cameroon and also have attended at least 2 General Meetings and demonstrate impartiality;
- have no current disciplinary sanctions.

#### For the position member of the Council:

- be of Cameroonian nationality;
- be a registered member of the Council;
- be up to date with their dues (absolutely feature on the list of 2,883 medical doctors who are up to date with their dues as of 14 December 2022);
- have at least 5-year seniority of medical practice in Cameroon in a specific board;
- commit to live and work in Cameroon permanently;
- be available;
- have not been convicted of a criminal or ordinary offence, in accordance with the provisions of the law;
- commit in writing to serve the Council and uphold to ethical and professional conduct.

#### For the position of member of the Chamber of Appeal:

- be of Cameroonian nationality;
- be a registered member of the Council;
- be up to date with their dues (absolutely feature on the list of 2,883 medical doctors who are up to date with their dues as of 14 December 2022);
- have at least 5-year seniority of medical practice in Cameroon in a specific board;
